<input type="checkbox"/>	3A Disabilities: (Same meaning used in Section 2626 of the Unemployment Insurance Code.)	Criterion 3 SDF. Documented learning disability or participation in or eligibility for Disability Support Program and Services.
<input type="checkbox"/>	3B Low family income: (Eligibility for or receipt of financial aid under a program that may include, but not be limited to, a fee waiver, Cal Grant, federal Pell Grant, CalWORKS.)	Criterion 3 SDF. Proof of eligibility for or receipt of financial aid e.g. California College Promise Grant (CCPG) formally BOGW, Cal Grant, Pell Grant or other federal grant, or CalWORKS.
<input type="checkbox"/>	3C First generation to attend college: First generation college students are defined by the U.S. Department of Education as “Neither parent had more than a high school education.”	Criterion 3 SDF. Typed and signed paragraph explaining the educational background of your parents.

Criterion 3 SDF and Criterion 1C SDF or 3D SDF Paycheck stub from the period of time enrolled in prerequisite courses or Criterion 3D Supporting Documentation Form from employer verifying employment while completing prerequisite coursework. If the Criterion 1C SDF was submitted for the period of time in which you were enrolled in prerequisite coursework, the Criterion 1C SDF can be used to document Criterion 3D.

<input type="checkbox"/>	3G Refugee status	Criterion 3 SDF. Documentation or letter from U.S. Citizens and Immigration Services (USCIS) verifying your refugee status.
<input type="checkbox"/>	3H Veteran Status	Criterion 3 SDF. Copy of Defense Department Form DD-214. Honorable discharge required.
